## **Overview of standards**

EU Conventional Production:

- Tethering of sows prohibited and use of sow stalls restricted to the first 4 weeks of pregnancy (farrowing crates permitted)
- Pregnant sows must be given sufficient fibrous or bulky food, as well as high energy food
- Nesting material must be provided to sows before farrowing
- At least 1.3m2 per sow area must be continuous flooring
- Pigs must have permanent access to a sufficient quantity of material to enable proper investigation and manipulation activities, such as straw, hay, wood, sawdust, mushroom compost, peat or a mixture of such (pigs are typically reared in barren environments regardless of this law)
- Routine tail docking and teeth clipping and grinding is prohibited (but commonly practiced)
- Surgical castration permitted up to 7 days of age
- Minimum space allowance prescribed by weights
- Piglets typically weaned at 28 days (minimum 3 weeks)

EU Organic Production – additions or differences compared to conventional legislation

- Sow stalls and farrowing crates banned
- Provision of ample bedding material
- Pigs must have access to pasture or an open-air exercise area or an open-air run. The final fattening stage (maximum 1/5 of total lifetime) can take place indoors
- Piglets weaned at 40 days
- Routine tail docking prohibited
- Greater space allowance given compared to EU conventional legislation specified by weights

UK production

• In line with EU legislation except sow stalls banned throughout gestation

Outdoor bred – UK production standards plus

• Sows are outdoors where crates and stalls are not used. The piglets are then brought indoors for fattening at weaning (around 3-4 weeks old).

Outdoor bred and reared – UK production standards plus

• 'Outdoor reared' means the meat pigs are reared outside for around half their lives (approximately 3 months). During this time they won't necessarily have access to pasture, but will be kept in an outside pen. Throughout their lives they should have access to plenty of bedding such as straw. Sows are outdoors where crates and stalls are not used.

Free range – there is no legal definition but should mean born and reared outdoors throughout life

## **Certification schemes**

Red Tractor Assured Pork – UK production standards plus

• Castration prohibited

**RSPCA** Assured

- Sow stalls and farrowing crates prohibited
- Castration prohibited
- Greater space allowance than UK production standards specified by weight
- Bedding material provided
- Tooth clipping and grinding prohibited
- Routine tail docking prohibited veterinary sign off to derogation

Soil Association

- Meat pigs kept free range for at least 80% of their lives
- Sow stalls and farrowing crates prohibited
- Castration prohibited
- Greater space allowance than UK production standards specified by weight
- Bedding material provided
- Tooth clipping and grinding prohibited
- Routine tail docking prohibited
