Part 1: JOB PROFILE

1. OVERALL OBJECTIVE(S) OF THE POST

The purpose of this role is to help end factory farming using scientific knowledge to bring about positive change. The objectives of the role are:

- To contribute to, and assist in developing the organisation's campaigns, liaise with associated • consultants and develop research and information-based resources for diverse audiences, as directed by the Head of Policy and in accordance with Compassion's strategic goals
- Advocate the case for dismantling factory farming to agreed academic and technical bodies. •

- Development and delivery of Compassion's technical and information resource needs including briefings • and information for the website
- Responding to, and managing, gueries generated by the SET and other internal and external sources • (with assistance from other staff, particularly the Research and Education Manager, as necessary)
- Responsible for managing day-to-day administrative tasks such as (but not limited to) ordering of • papers, tracking conference attendance, co-ordinating and disseminating conference feedback, managing input to data-managements programmes (e.g. Document Manager, InfoRouter, Asset Bank) and managing subscriptions
- Contribute to research projects from implementation to evaluation, in line with Compassion's strategic • plan, when required and as directed by the Head of Policy
- Contribute to enhancing the scientific analysis underpinning the design and delivery of Compassion's campaigns
- Work with other departments, including colleagues in our international offices, to develop and implement integrated projects, including knowledge management, resource development, marketing and distribution
- Liaise with a diverse range of stakeholders including supporters, media, academics, government • officers, food industry and farmers if required

5. PRIMARY RESPONSIBILITIES

Essential duties and responsibilities include the following: Other duties may be assigned.

Provide technical support for the Campaigns Team, as directed by the Head of Policy – 40%

- o Contribute to the technical science base for the Campaigns team
- Conduct research, desk-based or in the field, required to support key campaigns
- Write or contribute to reports, briefings, online material and other resources, managing their dissemination as appropriate
- Build and maintain constructive relationships with key consultants and other external stakeholders in the scientific, technical and related policy environments
 - Contribute to the organisation's project development and evaluation activities from a scientific perspective
 - Ensure effective communication between the department and other internal and external stakeholders
 - o Report any issues to the Head of Policy in a timely manner

Provide technical support to help deliver Compassion's internal science and information resource needs – 35%

- o Ensure effective information resources are available for key audiences
- o Assist other departments and Compassion's international offices with queries and research inquiries
- o Ensure factual accuracy of Compassion's documents and other resources
- o Ensure effective communication is maintained with strategic level directors via the Head of Policy

Support effective communication with diverse audiences via a range of media, including web pieces, reports, journal articles, press and media copy and video - 15%

- Help develop clear agreed briefs, work plans and budgets for resources to be developed as required
- Help plan, develop and deliver resources which meet the wider organisation's information requirements
- Liaise with consultants to develop research and content for communications e.g. reports as required
- Liaise effectively with other departments to ensure production of resources which meet the organisation's requirements
- Research, write or contribute to briefings and other online material in addition to that required for key campaigns in order to educate or inform the public
- Help to ensure key Compassion briefings, reports and other resources are effectively disseminated online or by other means where appropriate

Work with other departments and international offices to develop and implement integrated projects, including resource development, marketing and distribution – 5%

- Ensure regular and effective liaison and communication with other departments in planning, developing, implementing and evaluating projects when required
- Participate in campaign working groups
- o Input technical teams of the organisation to ensure the technical knowledge base of the organisation

Represent Compassion in a wide range of environments, including academic, policy and the media – 5%



- Help provide technical and policy comment to journalists and the wider media when required
- \circ $\,$ Help ensure research resources can respond quickly and effectively to media queries
- Attend meetings, give presentations / papers / other communications on behalf of Compassion in academic, policy and other environments as directed by the Head of Policy
- o Attend conferences to increase and update the knowledge base of the organisation
